WAIVER AND RELEASE OF LIABILITY

Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
- 3) Assume all the foregoing risk and accept personal responsibility for the damages following such injury, permanent disability or death.
- 4) Release, waive, discharge and covenant not to sue Etna Deck Hockey, its affiliated clubs, their respective administrators, directors, agents, coaches, and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers and if applicable, owners and lessors of premises used to conduct the event., all of which are hereinafter referred to as "releases" from any and all liability to each of the undersigned, his or her heirs and next of kin for any such claims, demands, losses or damages on account of injury, including death, damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.
